I(we) understand that if any portion of the balance remains unpaid after the due date, I(we) may be placed on a cash basis until that amount is paid. I(we) understand that a FINANCE CHARGE of 1.33%(16% APR) will be assessed on any past due balance (minimum charge of \$.50). Payments shall be applied first to any unpaid Finance Charge, then to the remaining outstanding balance due. In the event that collection proceedings must be instituted to collect any balance due, I(we) understand that I(we) may be subject to, and agree to be liable for, additional collection agency fees, court costs and/or attorney fees. All parties to the application agree to be bound by the terms of this Agreement, and each agree to be jointly and severally liable for payment of all purchases made under this Agreement. PCA shall have the right to limit or terminate the Agreement, as well as the resulting open account at any time, but such termination shall not affect my(our) obligation to pay any outstanding balance on the account. PCA may declare the entire outstanding balance due and payable in full at any time it deems necessary.

I(we) authorize all trade reference sources, banking/financial institutions and accountants to release information to Panhandle Cooperative Association as part of this Application.
